### Terms of Business

#### 1. TERMS OF PAYMENT

- a Final Payment due 30 days from date of invoice.
- b Disbursements and goods paid in advance by ourselves are to be paid via cash, card or bacs within 5 working days of arranging the funeral or 2 working days prior to the funeral date.
- c Unattended Funeral to be paid in full within 5 working days of arranging the funeral or 2 working days prior to the funeral date.

#### 2. PRICE VARIATIONS

If after the date of order the cost of the goods or services supplied is increased, we reserve the right to pass on these increases to the Buyer in proportion to the effect of the increase to ourselves.

#### 3. CHARGING OF INTEREST ON OVERDUE ACCOUNTS

We reserve the right to charge interest on any account not paid according to our Terms of Payment. This will be at the rate of 1 ½% per month or part month overdue. Interest will be added to statements and any interest due and unpaid will be left as an outstanding overdue balance.

#### 4. THE RIGHT TO CHARGE COLLECTION COSTS ON OVERDUE ACCOUNTS

We reserve the right to add to any overdue account the costs incurred by us in collecting the account through a third party acting on our behalf.
